

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 47-68

BEING A BY-LAW TO AMEND BY-LAW NO. 2265 OF THE CORPORATION OF THE CITY OF NORTH BAY, BEING A BY-LAW TO AMEND BY-LAW NO. 2100 OF THE CORPORATION OF THE CITY OF NORTH BAY, RELATING TO THE ADOPTION OF CERTAIN POLICY MATTERS.

WHEREAS the Council of The Corporation of The City of North Bay deems it advisable to amend by-law No. 2265 of The Corporation of The City of North Bay as hereinafter set forth:

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That paragraph 2, section 11 (b) be amended by adding after the words "City Clerk" in the fourth line the following:

"and a member of the staff of the District Assessor or in his place and stead a qualified local real estate agent from time to time designated by the Chairman of the General Government Committee and the Clerk of the municipality."

so that the section, as amended, now reads:

"The land shall be valued by the Real Estate Committee which shall be composed of the Chairman and Vice-Chairman of the General Government Committee, the City Clerk and a member of the staff of the District Assessor or in his place and stead a qualified local real estate agent from time to time designated by the Chairman of the General Government Committee and the Clerk of the municipality."

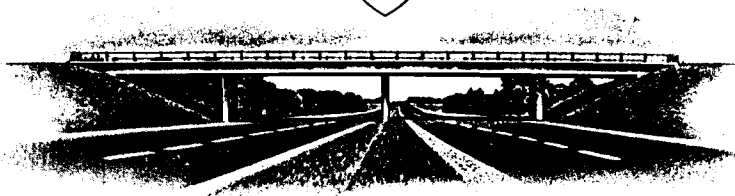
